In the interest of administration, following adjustments are hereby ordered with immediate effect:-

1. Mr. Akshay Choudhary, presently looking after the charge of the post of Chief Agriculture Officer, Poonch, shall look after the charge of post of Project Officer, Dryland, Jammu.
2. Rakesh Kumar Sharma, presently looking after the charge of the post of Seed Analyst, Jammu, shall look after the charge of post of Chief Agriculture Officer, Poonch.
3. Mr. Mohammad Iqbal Khan, presently looking after the charge of the post of Assistant Soil Conservation Officer, (CAD) Pulwama shall look after the charge of post of Floriculture Development Officer, Srinagar.
4. Mr. Aijaz Hussain Dar, presently looking after the charge of post of Soil Conservation Officer, Pulwama shall look after the charge of post of Chief Agriculture Officer, Ganderbal.
5. Mr. Waheed-ur-Rehman, presently looking after the charge of post of Potato Development Officer, Kashmir shall look after the charge of post of Soil Survey Officer, Srinagar.

The above arrangement in respect of S.No 2 to 5 shall be:-

- a. Purely temporary for a period of six months only to look after the work of charge of the post assigned till the post is filled up under rules by DPC/PSC whichever is earlier.
- b. Not confer any right of superior claim in favour of the officers for regularization and shall be without prejudice to the outcome of any writ petition(s) pending consideration before any competent court(s).



- c. Reversible without any prior notice to any officer(s) in whose case any adverse report/remarks are received from any organization/agency.
