**Government Order No. 115 – Agri. of 2017
Dated: 17 - 04 - 2017**

Sanction is hereby accorded for placement of funds amounting to **₹ 0.75 lacs (Rupees seventy five thousand only)** for meeting the expenditure on account of State Level Inception Workshop held on 04-03-2017 under the Project Management component of the "Climate Resilient Sustainable Agriculture in Rainfed Farming (Kandi) Areas in Jammu/Kashmir" in favour of Director Agriculture Jammu through Director Finance, Agriculture Production Department.

The sanction is subject to the following conditions during the implementation of the scheme.

- 1) Director Agriculture Jammu shall submit the Utilization Certificate in the format prescribed in GRF19A on quarterly basis for each instalment on quarter / half yearly basis.
- 2) All codal formalities shall be fulfilled before incurring expenditure under the scheme.
- 3) The Director Agriculture Jammu shall ensure that funds are utilized prudently and judiciously and in no case shall book the expenditure just for the sake of expenditure.
- 4) There shall not be any overlapping of the activities under the project with the activities of any ongoing state sector scheme/ central scheme / Centrally Sponsored Scheme.
- 5) The Director Agriculture Jammu /agency **shall maintain a separate bank account** for the purpose and shall ensure that no cash payment is made out of the same. The interest accrued, if any shall be treated as government fund and shall be deducted from the second instalment.

- 6) The Director Agriculture Jammu shall set all measurable parameters as given in the detailed project report and approved by the Steering Committee both at National and State level.
- 7) Review to be made by an independent body not having conflict of interest.
- 8) Evidence of deposit of TDS in case of contract payment and CST in case of liveable goods are sent alongwith Utilization Certificate. In case of employment through contract, copy of PF and ESI of employees shall be furnished.
- 9) Report of field visit by NABARD after each visit to be submitted to Ministry of Environment, Forest & Climate Change, GOI and the State Govt of J&K.
- 10) The accounts of the executive agency shall be open for audit by Central Government or CAG. The implementing agency shall furnish audits accounts with the UCs.
- 11) The Director Agriculture Jammu shall ensure that the scheme is completed within approved timeline/ cost of the project. No time and cost over-run shall be allowed under the scheme.
- 12) The Director Agriculture Jammu in consultation with Nodal Officer, J&K Climate Change Cell shall develop a mechanism as per para 10(i) of NAFCC scheme to monitor outcome on regular basis.
- 13) If the Director Agriculture Jammu does not utilize the funds for the purpose, for which it is given, the same shall be refunded with simple interest of 12% P.A.
- 14) The fixed asset created out of this grant shall not be disposed off, without concurrence of the Ministry of Environment, Forest and Climate Change.


