In supersession to the corrigendum issued vide endorsement No. Agri/PC-77/2018-19 dated 03-07-2018, it is enjoined upon all the Directors/MD JKAgros and Mission Directors/Nodal Officers of Centrally Sponsored Schemes viz., Rashtriya Krishi Vikas Youjna (RKVY), National Food Security Mission on Sustainable Agriculture (NMSA), National Mission on Oilseeds and Oil Palm (NMOOP), Pradhan Mantri Krishi Sinchayee Youjna (PMKSY), NeGP-A, Pradhan Mantri Fasal Bima Youjna (PMFBY) and Integrated Development of Sericulture Industry etc. to adhere the conditions laid down in the Sanction Orders issued vide Govt. order No. 92-Agri of 2018 dated 23-03-2018 in true letter & Spirit.

Besides, the implementing officers shall execute the works strictly as per the funding pattern of CSS (90:10) ratio and state share equivalent to the central share available/authorized during **the financial year be utilized strictly as per the guidelines of the CSS.**

Any violation to the instructions shall be the personal and exclusive responsibility of the concerned DDO/Controlling officer and shall be construed as financial irregularity and will be dealt under rules as financial indiscipline.
