In connection with the visit of Shri Kailash Choudhary, Hon'ble Minister of State (MoS) in the Ministry of Agriculture & Farmers Welfare, Government of India, for the public outreach programme in the Union Territory of Jammu and Kashmir scheduled on 09th & 10th June, 2022, it is hereby ordered that:

- I. Agriculture Production Department shall prepare a detailed itinerary of the Hon'ble Minister in advance in consultation with the office of the Hon'ble Minister and the Divisional Commissioner, Kashmir. The same shall be shared with the concerned Departments & Agencies viz Hospitality & Protocol Department, ADGP, Security, Director, Motor Garages, and GAD. Further, the Department shall make appropriate protocol arrangements including reception/see off for the Hon'ble Minister.
- II. Home Department/ADGP Security shall make adequate security arrangements for the programme.
- III. Transport Department/Director, Motor Garages shall make the required transport arrangements.
- IV. Hospitality and Protocol Department/ Director General, Hospitality and Protocol Department shall make appropriate boarding and lodging arrangements in connection with the visit.
- v. Deputy Commissioner, Pulwama shall be the Nodal Officer for the programme.
- vi. Agriculture Production Department shall nominate a Liaison Officer, with sufficient local knowledge for the visiting Hon'ble Minister and share the details in this regard with the office of the Hon'ble Minister and all concerned Departments/Agencies.
- vii. Deputy Commissioner, Pulwama shall appropriately brief the visiting Hon'ble Minister about local issues on his arrival.
- viii. Deputy Commissioner, Pulwama shall compile a report on the experience of the visiting Minister and share the same with the General Administration Department and the Planning Development & Monitoring Department subsequently.
