

Whereas, the General Administration Department vide communication No.GAD/MTG0RB-IV/63/2021-09-GAD dated 19.10.2021 forwarded the recommendations/selection list issued by the J&K Services Selection Board vide letter No.SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021 pertaining to Agriculture Department for appointment under the provisions of the J&K Appointment to Class-IV (Special Recruitment) Rules, 2020 notified vide S.O 184 of 2020 dated 04.06.2020;

Whereas, the General Administration Department had forwarded the selection list of the candidates to the respective Deputy Commissioners/District Magistrates with the request to ensure the filling of their character verification rolls and forward the same to the Director General, CID, J&K, Srinagar for verification of Character and Antecedents of the candidates. The General Administration Department, subsequently, requested all the Deputy Commissioners/ District Magistrates to forward the verification report in respect of Character and Antecedents of all the selected candidates as received from the Criminal Investigating Department (CID) J&K, directly to the appointing authorities so that the appointment orders of these candidates are issued;

Whereas, the appointment order in favour of Mr. Asim Amin Dar S/o Mohammad Amin Dar R/o Wanpora Qaimoh, District Kulgam who has also been selected as Multitasking Staff (Orderly) in Divisional Cadre, Kashmir under RBA Category has not been issued owing to the fact that the Criminal Investigation Department verification report in respect of his Character and Antecedents was pending from the office of Deputy Commissioner/District Magistrate, Kulgam.

Whereas, after the gap of more than 15 months, the Deputy Commissioner/District Magistrate, Kulgam vide letter No DMK/Verification/2022-23/562 dated 13.02.2023 has forwarded the Criminal Investigation Department verification report received from Criminal Investigation Department, Jammu and Kashmir vide No. CID/VB/2023/Final/2853-2873/KGM dated 01.02.2023 in respect of Character and Antecedents of Mr. Asim Amin Dar S/o Mohammad Amin Dar R/o Wanpora Qaimoh, District Kulgam who has been selected as Multitasking Staff (Orderly) in Divisional Cadre, Kashmir under RBA Category to the Administrative Department;

Whereas, in pursuance of Rule 14 sub para 5 of the Jammu and Kashmir Civil Services (Decentralization & Recruitment) Rules, 2010, notified by SRO- 375 of 2010 dated 21.10.2010, the case was examined and was forwarded to the General Administration Department for consideration which vide U.O No. GAD-CORD/93/2023 dated 23.06.2023 conveyed the approval of the Competent Authority which is reproduced as under;

"Sanction is hereby, accorded to the extension in the validity period of the select list in favour of Mr. Asim Amin Dar S/o Mohammad Amin Dar R/o Wanpora Qaimoh, District Kulgam for appointment as Multitasking Staff (Orderly) in Divisional Cadre, Kashmir under RBA Category, furnished by J&K Service Selection Board vide No.SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021, for a period of one Year in relaxation in Rule-14 Sub-Rule (5) of a Jammu and Kashmir Civil Services Decentralization and Recruitment Rules, 2010 issued vide SRO-375 dated 21.10.2010. The appointment of the candidate shall be further subject to fulfillment of the conditions predetermined by the Government from time to time. "

Consequent upon the above, and in continuation to Government Order No.173-JK (Agri) of 2021 dated 22.10.2021, sanction is hereby, accorded to the temporary appointment of Mr. Asim Amin Dar S/o Mohammad Amin Dar R/o Wanpora Qaimoh, District Kulgam as Multitasking Staff (Orderly) in Divisional Cadre,

Kashmir under RBA Category in the Pay Level SL-1(14800-47100) in Agriculture Department with immediate effect;


The appointee shall report to the Director Agriculture Kashmir within a period of twenty-one (21) days from the date of issuance of this order, if the candidate fails to join within stipulated time, he shall forego his right to appointment, and the same shall be deemed to have been cancelled ab-initio without giving any further notice in terms of the Circular No. 08-JK(GAD) of 2019 dated 04.12.2019 issued by General Administration Department.

The appointee shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:-

1. Academic/Qualification Certificates.
2. Matriculation/Date of Birth Certificate.
3. Health Certificate from the concerned Chief Medical Officer of the District.
4. Domicile Certificate issued by the Competent Authority..
5. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under any self-employment scheme has been availed by the appointee.
6. Valid relevant Category Certificate, if any applicable.

The appointment of the above candidate shall further be subject to fulfillment of the following conditions:-

1. The clearance received from the Criminal Investigation Department, J&K is provisional and it will be mandatory for the appointee to fill the Verification Rolls (V-Rolls) as available through the online mode under the Employees Verification System (EVS). Any false information provided by the appointee or any adverse finding subsequent to the V-Roll submitted electronically will result in cancellation of appointment without any further notice.
2. The appointee shall furnish an undertaking in the shape of Affidavit as per the **Annexure-A** to this Order.
3. The salary of the appointee shall not be drawn and disbursed unless & until the satisfactory reports in respect of genuineness of qualification/Date of Birth/Relevant category Certificate and Final Character & Antecedents Report is received from the concerned Authority/Agency.
4. The appointee shall be on probation for a period of two years.

5. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO 400 of 2009 dated 24.12.2009.
6. The inter-seniority of the appointee shall be determined as per the J&K Civil Services (Classification, Control & Appeal) Rules, 1956.
7. The appointment of the appointee shall be cancelled ab-initio, if it is found that he possess higher qualification than the prescribed one at any stage and he shall also be liable for criminal prosecution under law.
8. The appointment of the appointee shall be subject to outcome of writ petition(s) if any, pending before Competent Court of law.
