3. Not confer any right of superior claim in favour of the officers for regularization and shall be without prejudice to the outcome of any writ petition(s) pending consideration before any competent Court(s).
4. Reversible without any prior notice to any officer(s) in whose case any adverse report/remarks are received from any organization / agencies or from the Vigilance Organization (ACB).
5. Purely treated as look after arrangement for smooth functioning of the department and shall in no case be constituted as order to be followed in the placement of seniority list by way of being in order of arrangement.


