Whereas, the General Administration Department vide communication No.GAD/MTG0RB-IV/63/2021-09-GAD dated 19.10.2021 forwarded the recommendations/selection list issued by the J&K Services Selection Board vide communication No.SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021 pertaining to Agriculture Production and Farmers Welfare Department for appointment under the provisions of the J&K Appointment to Class-IV (Special Recruitment) Rules, 2020 notified vide S.O 184 of 2020 dated 04.06.2020; and

Consequent upon the above and in continuation to Government No.173-JK(Agri) of 2021 dated 22.10.2021, sanction is hereby accorded to the temporary appointment of following candidate as Class-IV, in the Agriculture Production and Farmers Welfare Department District Cadre, Jammu in the Pay Level (SL-1) (Rs.14800-47100) with immediate effect.

- 4. The appointee shall report to the Directorate of Agriculture Production & Farmers Welfare, Jammu within a period of 21 days from the date of issuance of this order. If the candidate fails to join within stipulated time, he shall forego his right to appointment and same shall be deemed to have been cancelled ab-initio without giving any further notice in terms of the Circular No. 08-JK(GAD) of 2019 dated 04.12.2019 issued by General Administration Department.
- 5. The appointee shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:-
  - 1. Academic/Technical Qualification Certificates.
  - 2. Date of Birth Certificate.
  - Health Certificate from the concerned Chief Medical Officer of the District.
  - 4. Domicile Certificate issued by the Competent Authority.
  - 5. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self-employment scheme has been availed by the appointee.
  - 6. Valid Category Certificate, if any applicable.
- 6. The appointment of the above candidate shall further be subject to fulfillment of the following conditions:
  - a) If upon verification, any certificate(s) produced by the appointee is proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio.
  - b) The appointment of the said candidate shall be governed by the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowance) and Fixation of Tenure Rules, 2020 notified vide S.O 192 of 2020 dated 17.06.2020.
  - c) The appointment shall be cancelled ab-initio, if it is found that the candidate possesses higher qualification than the prescribed one at any stage and he shall also be liable for action under law.
  - d) The appointee shall be on probation for a period of 02 years.
  - e) The inter-seniority of the appointee shall be drawn in accordance with the merit secured by the appointee in the selection list prepared by the J&K Services Selection Board.

- f) The appointment of the said candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- g) The appointment of the candidate is subject to the outcome of any writ petition(s)/OA pending before any Court of competent Jurisdiction.
