Consequent upon the approval conveyed by the Ministry of Agriculture & Farmers Welfare, GoI to the Project viz, "Establishment of Pesticide Residual Analysis Laboratory in Kashmir (at Lalmandi, Srinagar)" under PM-Rashtriya Krishi Vikas Yojana PM-RKVY (DPR) component vide above quoted reference and in the scope of S.O 15 dated:- 09-01-2020, the Administrative Approval is hereby accorded for the execution of work at an estimated cost of Rs. 19.46 Crores (Rupees Nineteen Crores & Forty Six lacs only) in favour of Director Agriculture, Kashmir.

The above Accord of Administrative Approval (AAA) is subject to the observance of following conditions:-

- That the Accord of Administrative Approval does not confer the sanction to book the expenditure which shall be booked subject to the availability of funds under PM-RKVY (DPR).
- 2. That the work shall be executed only after completion of all the codal procedures/formalities strictly in accordance with the standing norms/orders/guidelines/instructions issued by the Govt;
- 3. That the components/items projected in the estimates are prepared as per the Sanctioned scheduled Rates (SSR) in vogue;
- 4. That the standard specifications are followed as per CPWD, NBC and I.S codes standards;
- 5. That the drawings are vetted by the competent authority before execution of the work;
- 6. That the work shall be executed as per the approved specifications/designs/norms strictly as per the detailed estimates and requirements of the Department by utilizing quality raw material;
- 7. That the work shall be completed within the AA cost to the utmost satisfaction of the indenting Department and the expenditure shall be incurred strictly as per AA/Technical sanction accorded by the competent authority. No liability whatsoever shall be allowed/entertained;
- 8. That the final payment shall be released only on the basis of cost offer/actual work done claim, whichever is less, after due verification/authentication by the competent authority and after the work is completed/handed over to the Department;
- 9. That there is no overlapping of funds from any other scheme/source/project;
- 10. That the work/procurement shall be executed strictly as per cost estimates and specific drawings approved by the competent authority and no deviation shall be made in the drawing/designs/specifications of the work without prior approval;
- 11. That no further revision in the cost in respect of each component of the item shall be allowed;

- 12. That the executing agency shall maintain and produce the pre, during and post-execution photographs of the work along with latitude-longitude coordinates of the project location;
- 13. That the work shall be completed in all respects within the specified time frame as indicated in the DPR. No cost overrun/escalation shall be entertained;
- 14. That the work shall be taken up after fulfilling all codal formalities and shall be allotted through e-tendering/tendering as per rules in this regard;

15. That the working BOQS, based on approved design details/requirements, are framed as per J&K PWD schedule of rates for e-tendering purpose of each project;

- 16. That the rates for the items not covered in JKSSR or any other relevant schedule shall confirm to analysis of rates based on authentic data book, to be computed and approved by the competent authority well before intimation of tenders in accordance with set codal
- 17. That the lump sum provisions, either in terms of percentage or fixed as made for certain components of each DPR are provisional and shall be subjected to detailed estimates based on actual details requirements and relevant rates to be framed and approved by competent authorities well before invitation of tenders in accordance with set codal
- 18. That e-tendering mode is followed for fixation of the award of contract for execution of each project. Fragmentation of projects, while tendering is not allowed;
- 19. That the Accord of Administrative Approval shall not be construed as any rate approval to the project/detailed estimates or any approval for inclusion in the plan.
